Petition for true up of ARR for FY 2011-12, review of ARR for FY 2012-13 and determination of Aggregate Revenue Requirement & Retail tariff for FY 2013-14 for ED- Daman & Diu.

**ORDER**

ED- Daman & Diu licensee filed petition no. 90/2013 for approval of ARR and Determination of tariff for FY 2013-14. The Commission vide order dated 22.03.2013 approved ARR and determined tariff of various categories of consumers of the licensee.

The Commission in lines no. 1<sup>st</sup> and 2<sup>nd</sup> of para no. 3 at page no. 219 of the order dated 22.03.2013 gave following direction:-

**Quote**

*"The approved tariff of FY 2013-14 shall come in force with effect from 1.04.2013 and shall remain valid till 31.03.2014".*

**Unquote**

Elections of Lok Sabha 2014 are to be held in the months of April and May. Model Code of conduct has been imposed by the Election Commission of India.

The Election Commission vide letter no. 437/GOA-HP/2014/800 dated 18.03.2014 has written to this Commission "..... the Commission has 'No Objection' for holding meetings for fixing the revised tariff and for taking a final decision thereon. However, before implementing the same, prior concurrence of the Election Commission of India shall be taken."

Therefore, the Commission has to get prior concurrence of Election Commission before passing the order for approval of ARR and determination of tariff for FY 2014-15 which process is likely to go beyond 31.03.2014. Hence necessity has arisen to amend/correct/review the order dated 22.03.2013 on enforcement of the order dated 22.03.2013 from 1.04.2013 to 31.03.2014. Therefore, first sentence of lines no. 1<sup>st</sup> & 2<sup>nd</sup> of para no. 3 at page no. 219 of order dated 22.03.2013 is amended as under:-

"This order shall come into force from 1.04.2013 and shall remain in force till further orders."

\* As per Regulation 9 (II) of JERC (Conduct of Business) Regulations, 2009 "Coram is two". Whereas as per proviso of Regulation 9 (II) of JERC (Conduct of Business) Regulations, 2009 if Chairperson or the Member is prevented from attending hearing of which he has been given notice the Member or the Chairman as the case may be attending the meeting shall validly constitute the Coram. Post of the Member is vacant. According to provisions of Section 93 of the Electricity Act, 2003 no act or proceedings of the appropriate Commission shall be questioned or invalidated merely on the ground of existence of any vacancy or defect in the Constitution of the appropriate Commission. So the Chairperson only constitute a valid Coram.
