## Sub: Declaration of 220/66 KV Sub-station, Magarwada, Moti Daman and 66/11 KV Sub-station, Malala, Diu as Prohibited Area under Indian Official Secrets Act, 1923.

Whereas in the opinion of the UT Administration of Daman & Diu, it is necessary to declare of 220/66 KV Sub-station at Magarwada, Moti Daman and 66/11 KV Sub-Station, Malala, Diu as specified below to be "Prohibited Place" under the Sub-clause (d) of Clause (8) of section-2 of the Official Secrets Act, 1923 (Central Act XIX of 1923), on the ground that information with respect thereto, or the destruction or obstruction thereof, or interference there with, would be useful to an enemy;

And, whereas the Official Secrets Act, 1923 has been extended to the UT Administration of Goa, Daman & Diu on promulgation of the Goa, Daman & Diu (Laws) Regulation, 1962 and Goa, Daman & Diu Laws Regulation, 1963.

And, Whereas, as provide under clause (b) of Sub-section (1) of the section-6 Goa, Daman & Diu (Laws) of the ibid of 1962 and Clause (b) of Sub-section 7 of the Goa, Daman & Diu (Laws) Regulation of 1963, "any reference to 9 the State Government shall be constructed as a reference to the Central Government and also as including a reference to the Lieutenant Governer" i.e. the Administrator of Goa, Daman & Diu.

Now, therefore, in exercise of the power-conferred by sub-clause (d) of clause (8) of section-2 of the Official Secrets Act 1923 (Central Act XIX of 1923), the Administrator, UT of Daman and Diu hereby declares, with effect on and from the date of publication of notification in the Official Gazette of the Daman & Diu, that the 220/66 KV Sub-station at Magarwada, Moti Daman and 66/11 KV Sub-station, Malala, Diu as specified in the schedule below to be "Prohibited Place" for the purpose of the Indian Official Secrets Act, 1923 (Central Act XIX of 1923).
